

The purpose of this modification is to extend the period of performance to Blanket Purchase Agreement (BPA) #N68939-97-A-0017 from July 1, 2002 through June 30, 2005.

General Services Administration (GSA) has extended the period of performance on GSA #GS-35F-4514G through January 21, 2007.

Change paragraph 4 of the basic BPA to read:

The BPA will expire after a three-year base period from July 1, 2002 through June 30, 2005, or at the end of the Federal Supply Schedule (FSS) contract period, whichever is earlier; the BPA may be renewed for two additional one-year option years.
